### **Yang Berhormat Dato Seri Setia Dr Awang Haji Mohd Amin Liew bin Abdullah, CFA**

Dato Seri Setia Dr Awang Haji Mohd Amin Liew Abdullah ("Dato Dr Amin") was appointed as the Minister at The Prime Minister's Office and Minister of Finance and Economy II on 27 September 2018, and before that was holding the position of the Minister of Finance II from 30 January 2018. Prior to these appointments, Dato Dr Amin was the Deputy Minister of Finance (Investment), while holding the CEO position of Darussalam Assets Sdn Bhd ("DA"), an investment holding company owned by the Minister For Finance Corporation, Brunei Darussalam. Before joining DA, Dato Dr Amin held several key positions with the Brunei Government, including being appointed as the Permanent Secretary of the Ministry of Finance, the Permanent Secretary of the Ministry of Industry and Primary Resources and the Managing Director of the Brunei Investment Agency.

Prior to his tenure with the Brunei Government, Dato Dr Amin worked as a Crude Oil Trader with Brunei Shell Petroleum Co Sdn Bhd in the mid-nineties after returning from the United Kingdom where he worked for ICI Finance PLC as a research analyst in the late eighties / early nineties.

Dato Dr Amin currently serves on the boards of many Brunei Government linked companies in diverse sectors including telecommunications, medical services, hospitality, oil and gas, information technology and education.

Dato Dr Amin graduated with a First Class Bachelor degree from Queen Mary College, University of London in 1984 and both a Master degree in 1989 and a PhD degree in 1993 from Imperial College, University of London. Dato Dr Amin also holds a professional qualification as a Chartered Financial Analyst (CFA) since 2004. He is also a member of CFA Singapore.

Prior to establishing Eco Bumi Arkitek (EBA), YB Yanty Rahman was a Senior Architect with the Public Works Department, Ministry of Development of Brunei for 15 years. She is the first female President of Institution of Surveyor, Engineer and Architect (PUJA Brunei) for the term 2018 to 2019. Ten years into the establishment of Eco Bumi Arkitek, YB Yanty Rahman was appointed by His Majesty the Sultan and Yang-Di-Pertuan of Brunei Darussalam as one of the Brunei Darussalam Legislative Council (LegCo) Members, due to achieving distinction, for a term of five years effective from 2017 until 2021.

As a Legislative Council member, YB Yanty Rahman actively presents the equality of opinions in all the concerns raised, particularly on issues of education, skills and development, women and the economic growth. In order to do this, she actively reaches out to the society in the form of invitations for forums and as a speaker for numerous events. She has been appointed, among others, as the Board Member for the following institutions: Darussalam Enterprise (DARe) Brunei Darussalam from 2016 to 2023, The Brunei Economic Development Board (BEDB) from 2020- 2023, Authority for Brunei AITI (Authority for Info-communications Technology Industry) from 2018 to 2023, ASEAN Business Advisory Council and East Asia Business Advisory Council from 2016 until 2021. YB Yanty Rahman is also co-chairing Manpower Industry Steering Committee (MISC) for Construction under the Manpower Planning and Employment Council (MPEC), a committee that links industry, relevant regulating agencies and training and education providers with the aim to align the industry's demand to the right supply at the right time, both its quality and quantity.

MANAGING DIRECTOR AND CEO OF BRUNEI LNG

Hajah Farida is the first Bruneian female Managing Director (MD) of Brunei LNG in the 50 year history of the company and the first Bruneian female MD across the Brunei Shell Joint Ventures (BSJV). She is responsible for the production and sale of LNG – one of the main contributors to Brunei Darussalam’s economy. Farida’s appointment marks a key step towards diversity and inclusion and marks a significant milestone not only in Brunei LNG but across the oil and gas industry in Brunei.

Prior to this, Farida held the role of Commercial/Corporate Director of Brunei Shell Petroleum Co. Sdn. Bhd. (BSP) where she was the integrator of BSP Business performance overseeing the sales of gas and crude. Farida joined BSP in Information Technology, having earned her degree in systems modelling from the UK. Farida has over 25 years of diverse experience in the upstream (exploration and production) and gas business, with specific focus on business strategy and planning.

In 2012, Farida was assigned to the Integrated Gas Strategy and Portfolio team with Royal Dutch Shell Group (Shell) in the Hague as Senior Gas Integration Advisor. Amongst others, she was responsible for the mid to long-term fundamentals outlooks of the gas and LNG markets and supported the portfolio management of the Shell’s Integrated Gas business. Of note, in 2014, she was a member of the team that developed the Shell’s Integrated Gas strategy; providing a clear focus and direction in support of the Shell’s growth aspiration.

Farida is passionate about mentoring and coaching young talents across the BSJV’s. She aspires to motivate young Bruneian women and men to contribute to the wider world in their own.

As a Member of the Executive Committee on Climate Change of the Brunei Darussalam National Council on Climate Change, she has a huge appetite to build and create a sustainable environment for the future.
